

Pat Boyle: Treasurer and Membership Report:

There are (as of November 6, 1988) 130 members of M.D.T.S., In addition there are 13 individual (trail maintainers) and 12 organizations that receive news notes. The current mailing list therefore is 155.

There are (as of November, 1988) 131 Guide books and maps, and 185 patches.

As of November 4, 1988 there was \$1222.27 in the bank. Members were reminded that most of this sum must be reserved for the next printing of guide books and maps.

Trail Reports:

Turner Darden Eastern Section The Eastmn half of the M.D.T.S. is open and blazed; advice for Somerset Lake is to proceed as in the past across this area; after "development" route will be clarified.

Ron Gray : Western Section

Philadelphia Electric Company has advised there will be logging in the Conowingo and Broad Creek areas near the trail.

Cuff's Run area needs maintenance and other work.

Pinchot Park; there are seven miles of trail that need a maintainer.

Peach Bottom; work hikes scheduled for next summer for construction and blazing. June 25, July 16 and July 30, 1989.

Bob Bennett will act as P.R. for the University of Delaware; especially with publicity about work hikes.

Continued threats After the joy of sucess made possible by the work of many, many concerned groups last May, when, in June, the State of Delaware moved to purchase duPont and other lands crucial to hiking trails (and even more important to environmental concerns, water supplies and flood control), a new threat has developed.

> New Castle County Council proposed Dec. 8, plans to "improve" Hopkins Road between 896 and Thompson Station Road. Deadline for protest -December 15. The "improvement" would eventually create a four lane highway where there is now a winding country road that wanders through Carpenter Park, White Clay Creek Preserve, the newly purchased H.B. duPont lands and Middle Run Park. The effect would be that of Route 202 or Route 40 across trails and over park land.
