All Terrain Vehicle Law

Pennsylvania passed an All Terrain Vehicle Law which became effective Sept. 9, 1985. MDTs members should be aware that all ATV's used in Pennsylvania (except on private property) must be registered with The Dept. of Environmental Resources Snowmobile/ATV Unit. It is suggested by the Keystone Trails Association that "in the event you encounter an ATV on a hiking trail on STATE OWNED land, you should get the Registration Number on the vehicle ... and report it to the District Forester."
