
The York Hiking Club will be our host for a weekend of hiking, good food, good companionship, and a little M.D.T.S. business.

GENERAL MEETING MINUTES 8 June 1980 York Hiking Club Cabin

- In attendance: R. Ronald Gray, Jim Hooper, Dave Toland, Jane Sohns, Armin Sohns, Padraic P. Boyle, Katherine C. Boyle, Turner Darden, Bob Yost, and Bernie Frick.
- 2. The minutes of the last MDTS meeting on 24 Feb. 1980 were accepted as written.
- 3. Treasurer's report P. Boyle, Treasurer:
 Balance, 31 Jan. 1980: \$294.11
 Income: \$541.73
 Expenses: \$446.84
 Balance, 7 June 1980: \$389.00

Fart of the NDTS income was from contributions from Getty Cil Co., Sierra Club, and P.A.T.C. Treasurer's report was accepted.

- 4. The Internal Revenue Service, on 28 April 1980, granted MDTS federal income tax exemption as a publicly supported non-profit organization under section 501 (C) (3) of the Internal Revenue Code. IRS deductible, on MDTS business, is the cost of food and lodging and at 8 cents per mile the cost of travel. MDTS dues and contributions are deductible.
- 5. P. Boyle, membership chairman, reported that there are now 35 members in NDTS. He will compile an MDTS membership list. He mentioned that the NDTS brochure needs to have the applicant's telephone number included.
- R. Yost showed an MDTS publicity statement written by Maurice Forrester.
- P. Yost mentioned that Potomac Appalachian Trail Club has contributed to MDTS and has become an MDTS Supporting Club member.
- 8. The decision of MDTS reapplying for a KTA grant was tabled until the next MDTS meeting.
- It was determined that MDTS does not at this time have enough pieces of mail to apply for postal cost reduction as a non-profit organization.
- 10. Drafts of a cooperative landowner agreement drawn up by W. Fepperman were shown. Discussion of the agreement included: a. The length of time for cancellation of the agreement: 90 days up to 1 year.

- 10. b. Insurance Charge: Basic agreement costs \$53 per year; Additional \$15 per landowner per year if the landowner is insured.
 - c. Procedure in approaching the landowner.
- 11. R. Yost suggested that MDTS have a newsletter to go to MDTS members.

12. Progress Report:

- a. T. Darden scouted a section of M-D Trail from MD 7 east of Northeast, Md., north along a buried telephone cable line. He will contact the local representative of the owner. Bushwacking is expected near Perryville. A crossing of the Principio River is to be evolved.
- b. York Hiking Club is actively scouting in the section between Lock 12 and Otter Creek.
- 13. Next meeting date to be set in September 1980.
- 14. Meeting adjourned.
