A Morning Hike and an Afternoon Meeting In the White Clay Creek Valley

Saturday, December 6, 2008

The Mason-Dixon Trail hike, preceding the quarterly meeting on Saturday, December 6, will feature the trail's passage along the National Wild and Scenic White Clay Creek in the bi-state Delaware and Pennsylvania Park and Preserve (Map 9: w-e, mi. 11.4 to mi. 20.8). Because the Delaware Park Service has mandated that the trail be officially charted entirely along the river, removing it from its former forested hillside routes, the hike distance will be about seven and a half miles, or about two and a half miles shorter than the one described in the current Mason-Dixon Trail Map #9.

Participants should gather by 9:00 a.m. at the Pennsylvania Preserve Lot 1 parking area on London Tract Road. Lot One is located just before the junction of London Tract Road with Good Hope Road. A shuttle arrangement will take hikers to our start at Fremont Road for the hike back to Lot One. Bring water and a lunch, and dress as the weather on December 6th dictates.

All are welcome to the members and board meeting at 2:00 p.m. at the meeting room of the Pennsylvania Preserve in the historic Primitive Baptist Church. Hikers will have a preview of the Church which they will pass near around mile 5.

Directions to PA Preserve Lot One

From the North heading south on PA Rte. 896 (New London Road), after passing through the small borough of Kentblesville, in about half a mile take a left onto Good Hope Road. Stay on Good Hope until it ends in 3.2 miles where it merges on the right with London Tract Road. At this < shape juncture, take a sharp right onto London Tract and Parking Lot One will be immediately (about 20 yards) on your left.

From the South heading north on Rte. 896, after leaving Delaware and passing through a less-than-a-mile slice of the northeast corner of Maryland, you will enter Pennsylvania. In approximately 2.2 miles arrive at the juncture with Good Hope Road where you turn right. Stay on Good Hope until it ends in 3.2 miles where it merges on the right with London Tract Road. At this < shape juncture, take a sharp right onto London Tract and Parking Lot One will be immediately (about 20 yards) on your left.

Minutes of September 21, 2008 M-DTS Board and Members Meeting

On the basis of the hike preceding the meeting, there was general consensus that the broken marker at the exit of the trail from its course along the power line into adjacent woods (Map 9, w-e: mi. 1.4) be replaced as soon as possible.

Yvonne Blades reported that she and Sandy Weymouth, in late June, cleared the trail and refreshed blazes between Rolling Mill Rd in North East and the Stony Creek crossing (Map 7-E to W, Mile 0.3-2.9). Since then, Sandy has carried on with trail clearing and blazing heading west.

Yvonne Blades reported that Susquehanna State Park Crew Supervisor, has been working on a relocation of an unsafe eroded steep hill section of trail in the Park (Map 6: w-e, ca. mi. 16.5).

The Susquehanna State Park Crew Supervisor, and her crew have been working on a relocation of an unsafe eroded steep hill section of the MDT in the Park (Map 6: w-e, mi 16.5). Jim Hooper and Ron Gray took part in one of the work sessions.

Yvonne Blades noted that has been seeking to get the trail off road in the Conowingo area. In August, she attended the Conowingo Dam ground breaking ceremony for an elaborate "Fisherman's Wharf" to be built by Exelon. She learned from the Conowingo plant manager that this area will be the trail head for a new Lower Susquehanna Heritage Trail (http://www.lshgreenway.org/) that will connect Fisherman's Park to the LSHG headquarters office on Rte 1. Yvonne will arrange for a meeting with Mary Ann Lisanti of LSHG to discuss the possibility of the M-DTS making use of the LSHG trail when it is built.

Jim reported that there is need for one or two trail relocations in Apollo Park (Map 4)

Bo Hopkins has submitted for the record the following on Susquehanna State Park:
The work being done in Susquehanna State Park is a retoute moving the park's old "Spur 6" from it's current location to more sustainable land, and a more accessible point in a parking lot.
Susquehanna's staff, I as a member of the Maryland Conservation Corps, and my crew of 5, with the help of M-DTS, AmeriCorps, and Maryland's Parks & People Program for underprivileged youth, all contributed to the re-route's design and construction.

This new spur included lots of rock work! Rock armoring the trail tread, moving rocks that were in the way, and placing rocks to create steps, and in some parts, a rock spree was secured in such a way that the trail traverses over the rock pile. As my contract with the Park has ended and I have returned to being a full-time student, I am not sure of what the current status of the relocation is, or if it is yet open. When I last left the park, it was not yet open, and a little bit more work had yet to be done. Nonetheless, the new trail provides new trail building techniques, and moves the old Mason-Dixon Trail closer to the Deer Creek Bridge so one spends less time walking along Stafford Road to reconnect with the trail. Since the Spur's head is at a Parking lot, one can now easily access the trail from this point with little trouble finding a parking place near the Deer Creek foot bridge. As for the trail itself, despite having to traverse the rock scrambles, the trail offers the hiker a gentler ascent/decent of the hill, and offers the eyes a close look at the new, sustainable, trail building techniques.

"On the advice of the IT technical staff at Penn State York, I decided to use Paint.net, a free program, to revise the maps, rather than PhotoShop, which would have cost the MDTS close to \$500. So far, it seems to work fine to read the last iteration of the maps that Yvonne Blades sent me on CD.

I've asked for help from Jan Gipe, who is a trail maintainer for MDTS and is helping me with understanding and using the software . . . and we have met once to initiate the process. We will continue to meet until the project is completed, or until I can do it myself. We are adding a small note to each map indicating "NOTE: For most recent revisions to these maps refer to: www.masondixontrail.org". This will mean that we need a systematic way to show any revisions on the MDTS web site."

Yvonne is sending me the trail details from the back of the maps as word documents. So far I have this data for Maps 1 - 4. I will ask for help with revising this information from Jim Hooper and Ron Gray for the Western portion of the trail, and Bob Bennett and Yvonne for the Eastern section

Quarry Land/Murphy's Hollow Land Acquisition

In October the Pennsylvania Division of Conservation and Natural Resources (DCNR) made a first payment to the Lancaster-York Heritage Region in support of its successful negotiation, contingent on a hazardous waste check, for the transfer of a Quarry Land/Murphy's Hollow parcel to the York Farm and Natural Lands Trust. This open space acquisition provides a possible option for an attractive rerouting of the Mason-Dixon Trail in that area.
