Insurance:

M.D.T.S.'s Liability insurance will be cancelled at the current expiration date (November). The insurance company claims the premium is too low to continue to carry M.D.T.S.'s policy. Liability insurance has been required by utility companies to cross their property. The agent for M.D.T.S. is seeking a new insurance company. M.D.T.S.'s Board of Directors is currently awaiting further information.

Trail Maps and Guides:

All members in good standing are to receive Maps and Trail Guides free; all new members will also receive Maps and Trail Guides free. Pat Boyle will mail these to new members.

Pat Boyle will also formulate a reminder letter to those members : who have not as yet paid 1985 dues.

The cost to M.D.T.S. for a set of frail Maps and Guides is \$1.60. A set will retail for \$4.50, and will be sold wholesale in groups of five for \$3.00 each.

Trail Reports:

Northern End: Warren Raab will work with the Boy Scouts on a section of the M.D.T.S. from Whiskey Spring to Pinchot State Park(Pa.) Some of this section may have to be relocated as the Pennsylvania Game Commission wants the trail to run "parallel" to the road, and the current plans call for a "snake".

No changes anticipated through Pinchot Park and on to Wrightsville.

There may possibly be a change at Wrightsville.

Wrightsville to Normanwood Bridge--no change.

Normanwood Bridge to Philadelphia Electric is on a road.

Currently, the trail section that had been planned to cross the Susquehanna Park Land leased by the Philadelphia Electric Company is not open, and roads are being used to by-pass the property. Trail rights have not as yet been granted to M.D.T.S. by Philadelphia Electric Company; however, it is anticipated these trail rights will be granted in the near future.

Clair Piersol drafted a letter to the Philadelphia Electric Company inviting P.E. officials to our Ribbon Cutting Ceremony, and reminding them of anticipated Trail rights grant for M.D.T.S.
